### APPLICATION CHECKLIST

- Official High School Transcript of grades or if currently attending college, unofficial college transcript
- Copy of ACT and/or SAT test scores (youth applicants only)

# **Application due to CSPPA office no later than 4:00 pm March 1<sup>st</sup>.**

## **RULES AND GENERAL INSTRUCTIONS:**

Leadership, scholastic, and writing ability are the criteria by which applicants will be judged.

All applicants must have a biological or legal adoptive parent or grandparent who is a member in good standing with the CSPPA or be a member or spouse of member in good standing with the CSPPA.

Applicant must complete at least one semester or one quarter as a full-time student within one calendar year of receipt of scholarship award. Failure to complete one semester or one quarter as a full-time student will make the applicant liable for a full repayment of the award within the same calendar year.

This award is not based on financial need. Receipt of additional scholarships from other organizations will not disqualify candidates from consideration. The award is made in one payment to be used by the applicant as he or she sees fit.

## **The Following Merit Standards Will Prevail:**

Cover letter and essay.....	50%
Scholastic Merit.....	30%
Leadership and extra-curricular.....	20%

## **Required Items:**

- A. Formal cover letter.
- B. "C 1-2 page essay on a life-changing experience you had or a person you met and how it/they impacted your life. It is expected that the subject of your essay will be different from prior year applications. Essays of scholarship winners may be published in the monthly newsletter, *The Centurion*.
- C. Official high school transcript covering the 9<sup>th</sup> grade to the date of application. Must bear an original signature of the proper school authority. If applicant is currently in college, please submit an unofficial college transcript instead. This document must include the GPA.
- D. ACT and/or SAT test scores must be included but may be a photocopy. Adult applicants need not submit ACT or SAT scores.
- E. Current dated, signed, one - page letter of recommendation from one person in authority from the school currently attended by the applicant.
- F. One letter of recommendation from a member of the community that has personal knowledge of the applicant's ability, work habits, leadership, personality and integrity. (Not related to the applicant)
- G. Copies of exhibits of achievement in scholarship, leadership, athletics, dramatics, community service or other activities may be attached.
- H. Submit the completed application along with other required papers to the CSPPA during business hours no later than 4:00 pm on March 1.
